

Get your own in-house registered Workplace Assessor

A workplace assessor is a person, such as an experienced supervisor or manager, who works in an organisation that has trainees. They are registered with ServicelQ as a workplace assessor to assess employees in their workplace.

To be a workplace assessor you must hold the national Unit Standard 4098: Use standards to assess employees' performance, or demonstrate equivalent knowledge and skills.

You must be currently employed in a relevant workplace and be able to demonstrate that you have the technical expertise to assess against the applicable unit standards. Ideally, this means that you will have the unit standards listed on your New Zealand Qualifications Authority (NZQA) Record of Achievement, and have proven industry experience in the subject you wish to assess.

You must be able to communicate well, both written and verbally, as assessment involves keeping good documentation, and having probing discussions with employees.

Workplace assessor registration process

You will be provided the following documents:

- Workplace Assessor Application Form
- Workplace Assessor Code of Practice

You will need to complete the application form and acknowledge our Code of Practice has been read and understood. You will also be required to provide a copy of your CV and ID. Please make sure your CV clearly shows your experience in the area you are wanting to assess and any relevant qualifications.

You can also provide additional information in the form of a cover letter to summarise your experience.

Employer: Your employer will be required to complete the endorsement section.

ServiceIQ Sector Advisor: They will check your form for you and complete the scope programme number and endorsement section.

They will submit your application to the ServiceIQ Quality Assurance team on your behalf.
